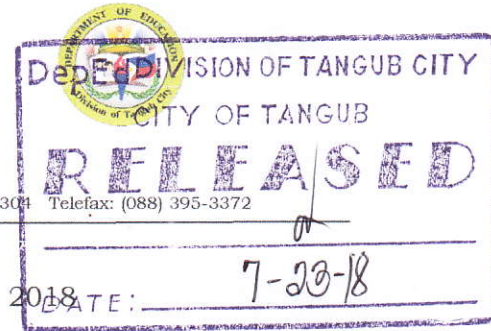

Conduct of School-Based Scouting

To: Chief, Curriculum Implementation Division
Chief, School Governance and Operations Division
Public & Private Elementary and Secondary School Heads
This Division

1. Pursuant to the approved BSP 2018 Calendar of Activities and as coordinated to the BSP Misamis Occidental Council, this Office hereby encourages schools to conduct school-based scouting activities from 3:00 in the afternoon of July 27, 2018 to July 29, 2018 on a stay-out basis. It is expected that activities undertaken are geared to develop good values per objectives of the scouting activities.
2. Participation to this school-based scouting activities is a pre-requisite for the 2018 Misamis Occidental Council – Wide Scouts Jamboree and Kab Scouts Olympics. Participants are required to submit parental consent prior to the conduct of said activities.
3. School heads, teachers, community and parents must ensure safety of learners. Membership to the BSP is voluntary and there is no quota required.
4. Schools which have NO trained personnel on BSP Basic Training Course are advised to coordinate and seek assistance to nearby schools with trained personnel or to the Division BSP Woodbadge Holders.
5. Facilitators to this school-based scouting activities are entitled to service credits depending on the number of hours they rendered services on Saturday and Sunday pursuant to DepEd Order No. 76, s. 2012 which reiterates DECS Memorandum No. 143, s. 1997 provides that service credits shall be granted for attendance in scouting activities.
6. School-based scouting expenses may be charged to PTA funds, school scouting funds, funds sourced from other stakeholders/ personal funds subject to the usual accounting and auditing rules and regulations.
7. For evaluation and enhancement of school-based scouting activities, school heads are required to submit a narrative report 3 days after the conduct of said activities.
8. Immediate dissemination of this Memorandum is highly enjoined.
