Invitation to Bid for Repair of Classroom to be used/converted to Dental/Medical Clinic of Sumirap CS and Tangub City CS

1. The Department of Education, Division of Tangub City, through the CY 2019 Dental Health Facility Program intends to apply the sum of 684,003.33 being the Approved Budget for the Contract (ABC) to payments under the contract for Repair of Classroom to be used/converted to Dental/Medical Clinic of Sumirap CS and Tangub City CS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Education, Division of Tangub City now invites bids for Repair of Classroom to be used/converted to Dental/Medical Clinic of Sumirap CS and Tangub City CS. Completion of the Works is required 120 Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Department of Education, Division of Tangub City and inspect the Bidding Documents at the address given below from 8:00AM – 5:00PM.

5. A complete set of Bidding Documents may be acquired by interested bidders on November 26, 2019 from the address below and upon payment of nonrefundable fee for the Bidding Documents in the amount of One Thousand Pesos (1,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Department of Education, Division of Tangub City will hold a Pre-Bid Conference on December 4, 2019 @ 9:00 A.M. at Division Library Hub, Division of Tangub City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before December 16, 2019 @ 2:00 PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 16, 2019 @ 2:00 PM at Division Conference Hall, Division of Tangub City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Department of Education, Division of Tangub City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
