Description

Invitation to Bid for Supply, Delivery, Installation and Configuration of Network Server and Rehabilitation/Upgrading of Existing Network Infrastructure

1. The DepEd, Division of Tangub City, through the FY 2021 GAA, intends to apply the sum of One Million Pesos (Php

1,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, Delivery, Installation and Configuration of Network Server and Rehabilitation/Upgrading of Existing Network Infrastructure. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DepEd, Division of Tangub City now invites bids for the above Procurement Project. Completion of the Works is required ninety (90) calendar days from the receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from DepEd, Division of Tangub City and inspect the Bidding Documents at the address given below from 8:00 AM – 5:00 PM, Monday-Friday, except holidays.

5. A complete set of Bidding Documents may be acquired by interested bidders on June 3, 2021 until 9:00 AM of June 23, 2021 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or electronic means.

6. The DepEd, Division of Tangub City will hold a Pre-Bid Conference on June 11, 2021, 9:30 AM at Division Office Conference Hall, 2nd Floor, DepEd, Division of Tangub City and/or through videoconferencing/webcasting via Microsoft Teams, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below and (ii) online or electronic submission as indicated below, on or before June 23, 2021, 9:29 AM. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on June 23, 2021, 9:30 AM at the Division Office Conference Hall, 2nd Floor, DepEd, Division of Tangub City and through Microsoft Teams. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
