



Contract Agreement

THIS AGREEMENT, made this 12th day of **July, 2021** between **Department of Education, Division of Tangub City**, Anecito Siete St., Mantic, Tangub City (hereinafter called the "Entity") of the one part and **SGA Trading** of SAV Bldg., Lapu-Lapu St., Corner Ecahvez St. Ext., Estaka, Dipolog City, Zamboanga del Norte, Philippines (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Bond paper for the Printing of Self-Learning Materials** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **One Million Seventy-Eight Thousand Seven Hundred Seventy-Seven Pesos and 50/100 (Php 1,078,777.50)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (*e.g.* bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. Contract duration or completion period shall commence within **TWENTY (20) CALENDAR DAYS**, seven (7) calendar days from the date of receipt of the **Notice to Proceed** by the Supplier, or on the date specified in the Notice to Proceed if a date is specified for a purpose.
4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
5. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


