INVITATION TO BID FOR THE Procurement of Supplies for the Reproduction of Learning Resources of Kindergarten to Grade 12 for the 1st and 2nd Quarter for SY 2021-2022

1. The DepEd, Division of Tangub City, through the Current Appropriations Flexible Learning Option R.A No. 11518-FY 2021 GAA intends to apply the sum of One Million Three Hundred Ninety-Five Thousand Nine Hundred Eighteen Pesos and 30/100 (Php 1,395,918.30) being the ABC to payments under the contract for the Procurement of Supplies for the Reproduction of Learning Resources of Kindergarten to Grade 12 for the 1st and 2nd Quarter for SY 2021-2022. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DepEd, Division of Tangub City now invites bids for the above Procurement Project. Delivery of the Goods is required within twenty (20) calendar days from the date of the NTP. Delivery should be at the DepEd, Division of Tangub City. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from DepEd, Division of Tangub City and inspect the Bidding Documents at the address given below during office hours, Monday-Friday from 8:00 AM-5:00 PM, except holidays.

5. A complete set of Bidding Documents may be acquired by interested Bidders on September 6, 2021 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000.00), DepEd, Division Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids.

6. The DepEd, Division of Tangub City will hold a Pre-Bid Conference on September 14, 2021, 2:00 PM at Division Office Conference Hall and/or through video conferencing or webcasting via Microsoft Teams with the link: <https://bit.ly/3yKuNFk>, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission or online submission at depedtangub.bacsec@deped.gov.ph and must be password protected at the office address indicated below, on or before Sept. 27, 2021 at 9:30 in the morning. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
