

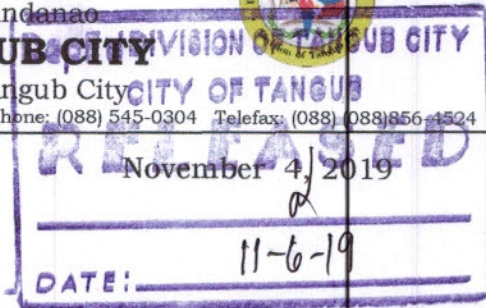


**TANGUB CITY DIVISION'S PARTICIPATION TO THE
