Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Department of Education (DepEd) - Tangub City Division and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm, Mondays to Fridays except holidays.
