



RESOLUTION TO AWARD

WHEREAS, the Division of Tangub City, Tangub City conducted a bidding on June 22, 2021 for the **Repair and Rehabilitation of Various School Buildings- 5 Classrooms of Sumirap Central School** with an ABC in the amount of **Two Million Five Hundred Thirty-Six Thousand One Hundred Thirty-Eight Pesos and 58/100 (Php 2,536,138.58)** ;

WHEREAS, ten prospective bidders responded in its Invitation to Bid, namely: JJFY Construction, ESL Milestone Builders and Supply Inc., NRMM Construction, JARM Construction, RSMA Builders and General Merchandise, MRTS Construction Services, Signo Associates Venture and Enterprise Corporation, RDT Construction and General Merchandise, BLAFF Construction and Supplies and Mitz and Nick Builders;

WHEREAS, only ESL Milestone Builders and Supply Inc., passed the initial evaluation of Division BAC and was declared eligible;

WHEREAS, the bidder offered the following bid:

WHEREAS, ESL MILESTONE BUILDERS AND SUPPLY INC., being the lone eligible bidder, underwent post-qualification and as evaluated offered bid in the total amount of Two Million Three Hundred Thirty-Four Thousand Seven Hundred Sixty-Four Pesos and Fifty-Five Centavos (Php 2,334,764.55) ;

WHEREAS, the Technical Working Group (TWG) was constituted to evaluate the technical documents for the project and to submit a report and recommendation of award on the bidding;

WHEREAS, the TWG submitted their report, recommending award of contract to ESL MILESTONE BUILDERS AND SUPPLY INC.;

NOW, THEREFORE, on mass motion of all the members present duly seconded in mass, be it;

RESOLVE, as it is hereby resolved to give the award to ESL MILESTONE BUILDERS AND SUPPLY INC. for REPAIR AND REHABILITATION OF VARIOUS SHOOOL BUILDINGS - 5 CLASSROOMS OF SUMIRAP CS.




