Resolution No. 036-2022

WHEREAS, the Division of Tangub City, Tangub City is in need of bidders for the **Procurement of Customized USB Flash Drive for the Regional Seminar Workshop on the Preparation, Reconciliation, and Submission of CY 2022 Mid-Year Financial Reports** with an Approved Budget for the Contract (ABC) of **Ninety-One Thousand Pesos (Php 91,000.00)**.

WHEREAS, one of the functions of the BAC is to recommend to the HOPE the mode of Procurement as indicated in the APP but cannot be pursued for the actual conditions applicability that also ensure that the most advantageous price for the government is obtained;

WHEREAS, BAC recommends such alternative method of procurement for the approval of the HOPE in compliance with NPM 169-2012 issued by the GPPB;

WHEREAS, the Bids and Awards Committee recommended that the **Procurement of Customized USB Flash Drive for the Regional Seminar Workshop on the Preparation, Reconciliation, and Submission of CY 2022 Mid-Year Financial Reports** thru BAC Resolution No. 031-2022, be procured through Alternative Method of Procurement- Negotiated Procurement under Small Value Procurement.

WHEREAS, on June 20, 2022 the procurement opportunity was published in the PhilGEPS website and the same was posted in the premises of the Division of Tangub City and its official website for at least three (3) consecutive days.

WHEREAS, after the deadline for submission of bids/quotations, there were five suppliers who responded to the procurement opportunity namely: NJSB Events Printing Services, SEMM General Merchandise, Corner 88 Stickerhouse, CRT Prints and Paglaum MPC.

WHEREAS, upon opening the Request for Quotation it was found out that the five prospective bidders are qualified bidders.


