DISSEMINATION OF THE LETTER FROM THE UNDERSECRETARY AND CHIEF OF STAFF ESPIMACO V. DENSING III RE: THE TASK OF THE TEACHER TO MONITOR AND GENERATE REPORTS ON PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps)
