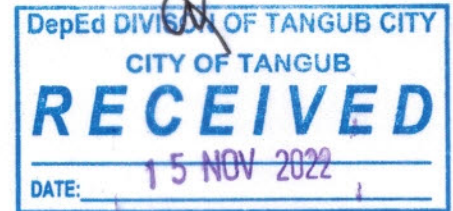

REITERATION OF THE MAINTENANCE OF TRANSPARENCY BOARD

It has reference to the Regional Memorandum No. 695, s.2022, dated October 28, 2022, re: the Reiteration of the Maintenance of Transparency Board.

This issuance reiterates Republic **Act No. 9485 or Anti-Red Tape Act of 2007** (An Act to improve Efficiency in the delivery of government Service of the Public by Reducing Bureaucratic Red Tape, Preventing Graft and Corruption, and Providing Penalties thereof), and **DepEd Order No. 13,s. 2016** on the **Implementing Guidelines on the Direct Release and Use of Maintenance and Other Operating Expenses (MOOE) Allocations of Schools, Including Other Funds Managed by Schools** under Section VI provision 27.4 on Reporting Requirements.

Concerning this, the Office of the Schools Division Superintendent requiring all schools both elementary, secondary and integrated schools in this division to post information on the sources, intended use, and actual utilization of school funds in their Transparency boards that must be accessible and updated every three months.

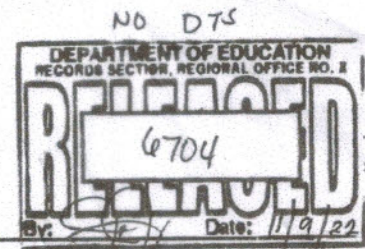

REITERATION ON THE MAINTENANCE OF TRANSPARENCY BOARD

To: Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

1. This issuance reiterates **Republic Act No. 9485 or Anti-Red Tape Act of 2007** (An Act to improve Efficiency in the Delivery of Government Service to the Public by Reducing Bureaucratic Red Tape, Preventing Graft and Corruption, and Providing Penalties Thereof), and **DepEd Order 13, s. 2016** on the **Implementing Guidelines on the Direct Release and Use of Maintenance and Other Operating Expenses (MOOE) Allocations of Schools, including Other Funds Managed by Schools** under Section VI provision 27.4 on Reporting Requirements.
2. Hence, this Office directs all Schools Division Offices (SDOs) to require all schools to post information on the sources, intended use, and actual utilization of school funds in their **Transparency Boards** that must be accessible and updated every three months.
3. This Office directs the immediate and wide dissemination of this Memorandum.
