Resolution No. 005-2023

WHEREAS, the Division of Tangub City, Tangub City is in need of bidders for the **Procurement of Office Supplies** with an Approved Budget for the Contract (ABC) of **Seventy-Three Thousand Nine Hundred Twenty-One Pesos (Php 73,921.00)**.

WHEREAS, one of the functions of the BAC is to recommend to the HOPE the mode of Procurement as indicated in the APP but cannot be pursued for the actual conditions applicability that also ensure that the most advantageous price for the government is obtained;

WHEREAS, BAC recommends such alternative method of procurement for the approval of the HOPE in compliance with NPM 169-2012 issued by the GPPB;

WHEREAS, the Bids and Awards Committee recommended that the **Procurement of Office Supplies** thru BAC Resolution No. 002-2023, be procured through Alternative Method of Procurement- Negotiated Procurement under Section 52.1 (b) Shopping.

WHEREAS, on February 23, 2023 the procurement opportunity was published in the PhilGEPS website and the same was posted in the premises of the Division of Tangub City and its official website for at least three (3) consecutive days.

WHEREAS, after the deadline for submission of bids/quotations, there were three suppliers who responded to the procurement opportunity namely: Zenn Variety Store, GEMMS Enterprises and Anas Multi Trade.

WHEREAS, upon opening the Request for Quotation it was found out that the three prospective bidders are qualified bidders.

WHEREAS, out of the five prospective bidders, **Zenn Variety Store** has the Lowest Calculated Responsive Quotation and has met the specifications stated in the Request for Quotation.



NOW, THEREFORE, we the members of the Bids and Awards Committee (BAC), hereby resolves as it is hereby resolved to give the award to **Zenn Variety Store** for the **Procurement of Office Supplies** in the amount of **Sixty-Nine Thousand Seven Hundred Seventy-Nine Pesos and 50/100 (Php 69,779.50)**.
