WHEREAS, on May 4, 2023 the procurement opportunity was published in the PhilGEPS website and the same was posted in the premises of the Division of Tangub City and its official website for at least three (3) consecutive days.

WHEREAS, after the deadline for submission of bids/quotations, there were three suppliers who responded to the procurement opportunity namely: Zenn Variety Store, GEMMS Enterprises and Wavemore Dry Good Trading

WHEREAS, upon opening the Request for Quotation it was found out that the three prospective bidders are qualified bidders.


